## FOCUS ON THE DEVELOPMENT OF YOUR CHILD

We believe that good collaboration between childcare and elementary education is the future. That's why we focus on an ongoing learning line for children from 0 to 13 years old. Our goal? To guide, stimulate and inspire children while growing up. This is how we lay a good foundation and enhance their chances and happiness in life.

### CHILDCARE AND EDUCATION GO HAND IN HAND

The connection between childcare and school is also practical: at most locations, we offer childcare and elementary school under one roof. We take care of your child at one familiar location, where childcare workers and teachers work together.

### WHAT IS PRE-SCHOOL?

Is your child between 2 and 4 years old? Then he or she is more than welcome at our pre-school. This type of childcare is a good preparation for elementary school. We offer pre-school for a minimum of two half-days a week. At most of our locations the children from 2 to 4 years old and the children from 4 to 6 years old often do activities together. Your child is already getting familiar with the kindergarten children, teacher and the new classroom. As a result, the transition to primary school goes smoothly.

### OPENING DAYS

The days of the week that pre-school is open, varies per location. All pre-schools are closed during school holidays and national holidays. Pre-school is only available during the 40 school weeks of the year.

### VVE INDICATION

In case your child is entitled to *voorschoolse- or vroegschoolse educatie* (VVE, issued by the *consultatiebureau*), yhe/she is also welcome at our pre-school. Children with VVE indication are entitled to two extra half-days of pre-school. The extra half-days will be funded by the municipality.

Diapers, fruit, drinks, bread lunch and snacks are included in this hourly rate. Does your child need customised food or diapers? We then kindly request you to provide it yourself.

### CHILDCARE ALLOWANCE

The mentioned prices in the table above are not the net prices the childcare cost you as a parent, if you are entitled to receive childcare allowance from the government: *kinderopvangtoeslag*. You can easily calculate the amount of your allowance and the net hourly rate, using the calculation tool on our website. The *Belastingdienst* calculates your allowance based on your taxable income. The hourly rates that we use are gross amounts and will be converted into a fixed monthly rate.

### HOW TO APPLY FOR CHILDCARE ALLOWANCE?

You need to apply for the allowance on the website of the *Belastingdienst* via *Mijn toeslagen* or by using the app *Kinderopvangtoeslag*. Don't forget to pass on price changes or a changed amount of hours of childcare. If you do so timely, you will receive the correct allowance. After starting the childcare, you need to let the *Belastingdienst* know within three months. In case of changes, you need to inform the *Belastingdienst* within four weeks.

### COMMUNICATION THROUGH THE PARENT PORTAL

As a parent, it is important to know how your child is doing, also when you are not around. We think communication with parents is very important. We communicate with parents through the parent portal. Here, you find photos of your child doing activities in the group, newsletters and messages, as well as bills, annual statements and other important documents like the terms, conditions and protocols.

Do you know in advance that your child will not be attending childcare at your regular day? Please let us know through the parent portal. It helps us with our staff planning. And it gives other parents the possibility to exchange a day. If you cancel a day of childcare through the parent portal, it will be turned into absence credit. You can check your absence credit in the parent portal.

You receive absence credit...	You can use the absence credit
If you let us know your child won't be attending childcare at least 48 hours in advance	30 days before the date or 60 days after
In case your regular day of childcare falls on a national holiday	30 days before the date or 60 days after

### EXCHANGE SERVICE

Our exchange service gives you the opportunity to swap a day (or half a day) of childcare. You can apply for the exchange days through the parent portal and use the absence credit without extra charge. You can find the terms and conditions of our exchange service on our website and in the parent portal.

### EXTRA PRE-SCHOOL

In addition to the two half-days of pre-school you can incidently buy an extra half-day of pre-school in case the placement falls under the childcare act. You can request an extra day of pre-school through the parent portal. The request will be reviewed by the group. You can expect a yes or a no four weeks in advance.

### NOTICE PERIOD

Do you want to end your contract or reduce the amount of days or half-days? The notice period is one month.
